The Regular Meeting of the LaFayette Board of Education was held on Thursday, November 13, 2014, at the Jr./Sr. High School-LGI. President Dodge called the meeting to order at approximately 5:34 p.m. Present were: Trustees Keefe, LaCava, Scofield, and Johnson. Also in attendance were Superintendent Lavine and Board Clerk Munnell. Others in attendance were: Administrators Jennifer Blossey, Susan Osborn, and Diane Ellsworth; Tom McCasland, Ann Schaefer, Gary Oelkers, Tom Irwin, Ellen Colter, Erin Oristian, Karen Hart, Betty Lyons, and Sidney Hill.

President Dodge led the participants in the Pledge of Allegiance

C. Opening Remarks

President Dodge held a moment of silence for Summer Rupert-Wozniczka, a co-worker of Trustee Johnson's, who was killed on October 30 while jogging. The Board of Education also extended its condolences to the Onondaga Nation Chiefs, Clan Mothers, Faithkeepers, and the Nation people for the recent passing of Chief Virgil Thomas. Chief Thomas was a Chief of the Turtle Clan.

President Dodge reported that congratulations were in order for Tim and Christine Baker on the birth of their son Samuel Perry Baker on Thursday, October 28, and to Tiffany and Radley Turner on the birth of their son Radley James Turner, on Sunday, November 2.

Other highlights: The Varsity Volleyball team is Section 3 Champions and the Varsity Football team is the first ever NFF Champions. The football team went undefeated! Congratulations to all of the student athletes and coaches.

- 7) Superintendent Report
 - A. Superintendent Updates Board
 - Superintendent Lavine thanked President Dodge for acknowledging the recent births to staff members, Tim and Chris Baker and Tiffany Turner. She also mentioned recent donations to our students. M & T Bank gave a piece of candy to each one our students who walked in the Grimshaw School Halloween parade. Seven Valley Realty Co. gave a donation to the Football Cheerleaders which they used to purchase pompoms for the team members. Ms. Lavine also recognized Mrs. Betty Van Alstine, grandparent of a Grimshaw student, who knits hats for students for their use in the winter months.
 - The Response to Intervention Design Team which consists of 14 staff members has been meeting to develop a plan for struggling students. They will be attending a two-day workshop in Albany on November 17 & November 18.
 - Mr. Scofield, Ms. Osborn, Mr. Ed McGraw gave a presentation at the NYSSBA conference in New York City representing LaFayette and the Big Picture School at the state level.
 - Superintendent Lavine thanked the Board of Education Trustees for attending the recent Child Abuse training workshop.
 - The new website is almost ready to be launched. The secondary pages need to be updated.
 - Ms. Lavine talked about the APPR process where it is necessary for her to observe the Principals observing Teachers. Ms. Lavine also will observe the Principals conducting Faculty meetings.
 - A recent change in the Capital Project in the renovation of the Main Office and Nurse's Office, creates a cost savings of \$50,000.

- Karen Ocque, Director of Instruction and Pupil Services, officially started her employment with LaFayette on Monday, November 10. Mary Conroy, Director of Special Education finished her employment but she is a Scholastic employee and will continue to work with our Read 180 teachers.
- The Smart School Bond Act proposed by Governor Cuomo passed recently. The District is allocated \$857,397. The Act is to provide access to classroom technology and high-speed internet connectivity to equalize opportunities for children to learn, to add classroom space to expand high-quality pre-kindergarten programs, to replace classroom trailers with permanent instructional space, and to install high-tech smart security features in schools. The State Education Commissioner has not worked out all the challenges but the School District should know in a couple of months what we should expect.
- Ms. Lavine is emailing the Board members "good" news from each administrator about what is going on in their areas.
- On Wednesday, Principal Ellsworth, Superintendent of Buildings and Grounds Kesler and Superintendent Lavine met with representatives of the State Education Department at the Onondaga Nation School regarding their proposed renovations. The SED sent their own architects to take a look at the plans. With the assistance of Assistant Commissioner Chuck Szuberla, we are hoping the project gets put into the Governor's budget. This is the farthest the project has gotten with SED.
