Regular Board Meeting - Amended January 24, 2013 Minutes

I. <u>Call to Order</u>

The Regular Meeting of the LaFayette Board of Education was held on Thursday, January 24, 2013, in the C. Grant Grimshaw School Library. VI. District Presentations and Reports

A. Presentation

1. Margaret DeNeve – American Cancer Society representative on "Relay for Life". She informed the Board that Relay for Life is the premier signature event and the largest fundraiser for cancer research and patient programs in the world. There will be an event at Tully High School on June 14 & 15 from 6:00 p.m. to 6:00 a.m. She left information for buildings to send out to students and families to participate.

2. Physical Education Department led by Karyn Meaney – Karyn introduced Stacy McNeill from BOCES who was key in providing support and guidance on what needed to be included in the plan to be in compliance with the State Education Department. The P.E. Department worked on the project for about 7-8 months. Karyn explained to the Board the process that was involved in creating the Plan. The Plan first needs to be approved by the Board of Education before it can be sent to the State. The State reviews the Plan and will assess whether or not the Plan is in compliance. Karyn stated the Plan will be posted on the LaFayette website.

Superintendent Tigh recommended to the Board to approve the Plan. A motion was made by Trustee Scofield and seconded by Trustee LaCava.

B. Oral Communications

- 1. Community Connections: Trustee Sofranko shared with the Board several recent news articles from the Post Standard and STARS:
 - a. A Thank You Note from Loretto Health and Rehabilitation Center for the LaFayette Jr./Sr. High School students that sang during the holiday season.
 - b. An article highlighting Cassley Jackowski reaching 1,000 points. Cassley is the first Lancer Girl or Boy to achieve this goal in the history of LaFayette basketball. Congratulations, Cassley!
 - c. 2013 Scholastic Art Awards were announced: LaFayette had 12-Gold Key; 10 Silver Key; and 13 Honorable Mention winners. More than 4,500 works of art were submitted for this year's competition from 90 Junior and Senior High Schools in 13 CNY counties. They selected more than 1,000 works which are on display at OCC's Whitney Applied Technology Center through March 1.

VII. Old Business

- A. Trustee Scofield recapped the Board details of the School Safety Meeting that was held on January 14 at the High School LGI. He said they talked about combining plans of securing schools and what to do during a lock down. LaFayette is ahead of most Districts in school security. The current conversation topic is "What more can be done." And is the New York State going to provide additional aide to cover this expense for Districts. There is another meeting scheduled in Auburn in February.
- B. Trustees LaCava, Dodge, and Whitney and Superintendent Tigh attended a meeting with LaFayette Town Supervisor Shute regarding evening use of school buildings by community groups. One suggestion is to have a sign-in/out sheet. It was noted that there is need for security and vigilance.

VIII. New Business

A. Superintendent Tigh reported that Deb Ayers, Assistant Superintendent for Administration at BOCES, has a proposal regarding a Local Efficiency Grant Study for a possible Regional Facility for Transportation. The study has \$50,000 and the districts would share each 10% or \$5,000 to participate. It would mean local districts voting to join a consortium to share one garage – one fleet.
