Regular Board Meeting May 20, 2014 Minutes

I. <u>Call to Order</u>

The Regular Meeting of the LaFayette Board of Education was held on Tuesday, May 20, 2014, at the Jr./Sr. High School Library. President Scofield called the meeting to order at approximately 5:30 p.m. Present were: Trustees Akl, Dodge, Keefe, Whitney, Sofranko and LaCava. Also in attendance were Superintendent Tigh, School Business Official Nesbitt, and Board Clerk Munnell. Onondaga Nation Representative Jacques was excused for the meeting. Others in attendance were: Administrator Laura Lavine, Karyn Meaney, Tom LaRose, Tess Miller and Don Dodge.

- II. <u>Pledge of Allegiance</u> President Scofield led the participants in the Pledge of Allegiance.
- III. Opening Remarks President Scofield mentioned there will be a short Executive Session at the end of the meeting. He also stated the annual budget vote was taking place in the foyer of the High School Lobby.

VI. District Presentations and Reports

- A. Presentation Tom LaRose, Grimshaw School Physical Education Teacher and Karyn Meaney, High School Physical Education Teacher had a wonderful video and PowerPoint presentation regarding the Physical Education program at the Grimshaw School and High School. Mr. LaRose outlined how the GS related the P.E. program to the Common Core and how the students loved the "Fitness" unit. Mrs. Meaney shared with the Board that the teachers joined together with the Onondaga Central District an Archery workshop. They were trained a specific way and Mrs. Meaney reported she was glad they did because they could better teach the students in the same manner. The students enjoyed the Archery unit. She also thanked the Board for continuing the Sr. P.E. classes that go off campus for some of their activities. The off campus unit teaches the students activities that they can continue when they finish high school.
- B. Oral Communications: Community Connections: Trustee Akl reported the Girls Lacrosse won 12-7 over Jordan-Elbridge. She also said she recently saw articles from SU and the NCAA reporting on the Thompson Brothers from the Onondaga Nation and they mentioned they attended LaFayette School. President Scofield said he was happy to report that he saw some students taking part in a political science venture. The students were supporting potential Board members and Budget Vote by holding signs and encouraging community to remember to vote. He also reported that Cassidy Doster and Paige Skinner were mentioned in the Post Standard for their recent wins for the Girls Lacrosse team. The Post Standard had pictures and statistics. Trustee Sofranko inquired about the percentage of participation for Grandparents Day. Superintendent Tigh said a student can have a grandparent "adopt" them if they do not have a grandparent who is able to attend. Trustee Sofranko said the Meet the Candidate Night went well but it was short notice. Trustee LaCava was out of town and could not attend. The Board made the suggestion of contacting parent groups or community groups to host the meet the candidates' event and having it put on the District Calendar annually.
