Regular Board Meeting October 23, 2014 Minutes

1) Opening

A. Call to Order

The Regular Meeting of the LaFayette Board of Education was held on Thursday, October 23, 2014, at the Jr./Sr. High School-LGI. Results of Survey and Unveiling New Website Superintendent Lavine reported on the continuing progress being made in improving communication throughout the District, specifically about the plans for a new website and an "app" for the District. She introduced Danica Kaltaler, Public Information Specialist, and Joshua Seitz, Webmaster from OCM-BOCES. Danica relayed the results of the Google survey that was offered on the website. She was pleased with the number of responses. There were 140 responses which was more than any other district she has worked with. She presented a Powerpoint breakdown of the results. She also gave the Board handouts with the outcomes.

Danica showed the Board members a draft of the new website design resulting from the survey responses. The Board was very receptive and excited about the new proposed website. It will be several weeks before the website would be up and running.

Josh and Danica talked about the free mobile "App" being created. Users can download it into their Androids or iPhones. The District will be able to push notifications and expect that it will be a great public relations resource.

It was a wonderful example of how students learn self-reliance through our teaching.

Ms. Lavine recently attended a parent group (PASS-Parent Advocate for Student Success) meeting. She thanked the parents for their work and for including her in their discussions. LaFayette asked and was selected to participate in the "YouthTruth Survey" which is designed to allow student to communicate how they feel about school and provide a vehicle for their voices to be heard. When the results come in, Ms. Lavine will share with the Board.

An update on the Capital Project: Mrs. Turner reported that we are pleased to have received a prompt reply from the State Education Department. They approved the first round of submittals and have made their recommendations to the architects. The architects will make the changes and submit for a second round of comments.
